CONTRACT REGULATIONS

By signing this contract you, the Buyer(s), have purchased for your dog(s) a membership in Red Dog Park. Buyer(s) agree(s) that the annual membership fees are **non-refundable** unless Red Dog Park is no longer able to provide a substantial number of the services offered when this contract was signed, in which case Buyer(s) will receive a prorated refund.

Buyer(s) agree(s) that the membership is **not transferable** to another dog owner. Other dogs owned by the Buyer(s) may be substituted for those named above provided they are approved of by Red Dog Park management.

Additional dogs owned by the Buyer(s) may be added to those named above provided the dogs are approved of by Red Dog Park management and the pro-rated difference in membership rate, if any, is paid.

Buyer(s) may cancel this contract without penalty or obligation (and receive a pro-rated refund) within 7 calendar days of the date membership begins. Red Dog Park reserves the right to deny entry to the facility or membership in the facility for any reason, and to terminate membership or expel a person and/or dog from the facility for any reason. If Red Dog Park terminates a membership, the corporation reserves the right to either return pro-rated fees or no fees.

RELEASE AND WAIVER OF LIABILITY AND ASSUMPTION OF RISK

Red Dog Pet Resort & Spa, LLC has created Red Dog Park for dogs and their owners and guests to enjoy together. I understand that the use of this park and other Red Dog Park facilities means that I am taking certain risks of damage or injury to myself, my guest(s), my property, my dog(s) and to others in the park and associated facilities. Included in these risks are negligence on the part of Red Dog, its owners, employees, customers and guests. I realize that when dogs are around strange people and other dogs, some accident or injury may result, and that people, dogs and property might be injured or damaged.

Because I want to use and enjoy Red Dog Park and its associated facilities, I hereby agree to assume these risks, for myself, my guest(s), my property, and my dog(s). I agree to make an inspection of Red Dog Park property, and to continue to stay vigilant regarding the property and regarding my guest(s), my property, and my dog(s). I agree that it is solely my responsibility to determine whether the Red Dog Park property itself and any particular situation involving other members, guests and dogs is safe for myself, my guest(s), my property, and my dog(s).

In exchange for the opportunity to use this facility, according to the Rules and Regulations, I hereby release and discharge Red Dog Pet Resort & Spa, LLC, and its owners, members and employees from any and all liability, claims, demands, causes of action, loss, damage or injury to person or property, including negligence, breach of contract, breach of any statutory duty of care, or any death and serious injury which may result while I or my guest(s) or my dog(s) are on the Red Dog Park premises.

I also agree to be responsible for my guest(s) and my dog(s) and for any liability caused by me, my guest(s) and my dog(s), and that I will hold harmless and indemnify Red Dog Pet Resort & Spa, LLC, and its owners, members and employees from any and all liability, claims, demands,

causes of action, loss, damage or injury to person or property, including any death and serious injury which may be caused by myself, my guest(s) or my dog(s) while they are on the Red Dog Park premises.

I agree to waive, release and forever discharge any and all claims, whether known or unknown, that I now have or may have in the future against Red Dog Pet Resort & Spa, LLC and covenant not to sue Red Dog Pet Resort & Spa, LLC with respect to my use of the Red Dog Park and its associated facilities.

I am 18 years old or older and have the legal capacity to enter into a binding contract. I intend for this release to be binding upon my heirs, beneficiaries, next of kin, personal representative or executor, and assignees.

RULES AND REGULATIONS

Please initial each rule to indicate that you have read it, understand it, and agree to abide by it.
Keep an eye on your dog at all times, and keep your dog's leash with you.
Poop: Clean up after your dog! No exceptions!
Do not let anyone other than your own people guests through the member gate at any time, regardless of whether the people wanting in have a dog with them or not, or if they say they are a member or not, or if they have a personal pass code or not. Disregard of this rule may result in termination of your membership. Direct them to the office; if the office isn't open tell them they will need to call the Park or return when the office is open.
Dogs must be on leash unless they are in the off-leash park; in the off-leash park dogs should be off-leash unless they are being led from one area of the park to another or in the exterior nature walk area.
No bullies! Rough play is fine as long as it is consensual. Rough play and chasing are not acceptable if any of the dogs involved are not comfortable with the situation. Just because a dog's intent is to play does not make the dog's behavior acceptable or tolerable if the other dog is not enjoying itself. Mounting should be discouraged as it is generally not enjoyed by the dog being mounted. All dogs deserve to have a good time at the Park!
Digging holes: Do not let your dog dig holes.
Dogs must be up-to-date on shots , including rabies. Rabies tags should be worn. Puppies must be 3 months or older and have 3 sets of boosters and bordetella.
Children. For safety reasons, children under 16 years of age must be accompanied by an adult and must be closely supervised at all times. Children must not be allowed to run, scream, chase the dogs, or pet another person's dog without first getting that person's permission.
Intact/Unaltered. For safety reasons, we must insist that dogs over 6 months of age be spayed or neutered to use the Park. Please note that even if the intact dog is wonderfully behaved, the presence of an intact doge may cause other dogs, even spayed or neutered dogs, to become more aggressive.
If aggressive behavior is observed, take immediate action: move your dog to another area of the park, leave the park, or do whatever you have to do to prevent the behavior from reoccurring (time-out, redirect behavior, etc.)
